We act on your behalf in arranging and managing your insurance requirements unless otherwise disclosed. In cases where we operate under a Binder arrangement and represent the insurer, this will be clearly noted on your invoice or quotation.

#### Our Services to You

As your appointed insurance broker, we will provide the following services:

- Quotation and Placement: Obtain insurance quotes from providers with whom we have established arrangements. (This may not apply where we act under a Binder.)
- Policy Negotiation and Renewal: Negotiate insurance terms and coverage annually, or as otherwise agreed.
- Coverage Arrangement: Arrange insurance cover based on your authorisation. In time-sensitive situations and where it serves your best interest, we may proceed with arranging cover unless instructed otherwise.
- Premium Funding Options: Where appropriate, we may offer premium funding options at the time of quotation. You may also request a funding quotation at any time.
- Claims Assistance: Assist in preparing, lodging, and managing insurance claims and advocate on your behalf throughout the process.
- Policy Changes and Cancellations: Implement changes or cancellations upon your instruction.

We maintain relationships with a wide range of insurers and underwriters to provide competitive and tailored options. Some insurers only deal directly with customers — we will advise if any such limitation affects your options. A full list of our insurance providers is available on request.

Where appropriate, and based on our market expertise, we may recommend retaining your current insurer if we believe the terms remain competitive. Additionally, we can assist with risk assessment, insurance planning, and mitigation advice — please note that additional fees may apply for these extended services.

# **Policy Cancellations**

If you cancel a policy mid-term, any refund will reflect the net return premium from the insurer. Brokerage and broker fees for the original placement are generally non-refundable. A cancellation processing fee may also apply.
